WHY IS BDS DANGEROUS?

BDS disguises itself as a human rights movement, but that couldn't be further from the truth. BDS is the 21st Century incarnation of an old disease: anti-Semitism. The difference is that now the entire Jewish state is targeted, not only the Jewish people. Israel's right to exist in challenged, Israeli companies are blacklisted, advocates for Israel are harassed, and artists are pressured to cancel their visits to Israel. We know what anti-Semitism can lead to, and we must not stand by and allow history to repeat itself.

WHAT ROLE CAN THE UN PLAY AGAINST BDS?

In 2014, the UN held its first ever summit against anti-Semitism. The nations of the world agreed upon a joint statement to address concerns of a rise in anti-Semitism violence globally and committed to eliminate anti-Semitism in all its forms. Unfortunately, we see troubling signs of things going in the wrong direction at the UN. Earlier this year, the UN Human Rights Council voted to establish a database of companies who are doing business with Israel. This "blacklist" is all too reminiscent of dark periods in our history when Jewish businesses, or those who sought to conduct business with us, were boycotted and sanctioned. We will not allow this to happen.

We expect the UN member states to recommit to their pledge to eradicate anti-Semitism, including BDS, the newest version of one of the world's oldest forms of racism and bigotry.

WHAT CAN STUDENTS DO TO FIGHT BDS?

This year, I spoke at Florida International University, my alma mater, with the intention of telling the truth about Israel to the students. Among those who came to the lecture were BDS activists. They didn't come to listen. They came to incite. I explained to the students who had come to support Israel that simply ignoring BDS is not an option. Only a coalesced effort, a united front, can amplify the truth, stop the lies, and eventually put an end BDS. How can we do that? This guidebook offers tips and ideas to fight BDS, shatter the lies, and spread the truth about Israel – so each and every one can be an Ambassador Against BDS.

BDS throughout the Years



The BDS Movement is a global campaign promoting the

It is the newest weapon in the ongoing effort to eliminate Israel as the democratic state of the Jewish people. **BDS** disguises itself as a progressive human rights movement, but nothing could be further from the truth. In reality, BDS is modern-day anti-Semitism that targets the Jewish state instead of Jewish people. It denies the Jewish people their right to self-determination and deploys traditional anti-Semitic rhetoric against Israel and its supporters.

Why is BDS Anti-Semitic?

Anti-Semitism is defined by the "Three D's" test. The BDS Movement has adopted all three and applied them to Israel:

- Double standards singling out Israel for criticism while considering the more egregious behavior of major human rights abusers around the world as permissible.
- Demonization Using symbols and images associated with classic anti-Semitism, such as swastikas and Nazism, to characterize Israelis or Israel is anti-Semitic.
- Delegitimization denying only Israel's fundamental right to exist, out of all the peoples in the world, as exemplified by their calls for a "one state solution."

What are the Roots of BDS?

The Movement was officially launched in 2005, but the underlying dogma at the heart of BDS has a long history. Extremists have been calling for anti-Jewish, anti-Israel boycotts since the 1920's. The first boycott against Jews in the British-controlled Palestine Mandate was called for by the Palestinian Arab Executive Committee, led by Nazi collaborator Haj Amin al-Husseini, in 1933. In 1945, fifteen Arab nations imposed boycotts against pre-state Israel, subsequently expanding them when Israel was established, in 1948.

The origins of BDS were also witnessed at the 2001 Durban "NGO Forum against Racism, Racial Discrimination, Xenophobia and Intolerance," which was marked by vitriolic expressions of anti-Semitism by a group of radical NGOs. The Forum claimed that Zionism was a form of racism, and that Israel is an apartheid state. The Forum's concluding statement declared that Israel was guilty of "racist crimes including war crimes, acts of genocide and ethnic cleansing," and it promoted a policy of complete and total isolation of Israel, the imposition of mandatory and comprehensive sanctions and embargoes, and the full cessation of all links between all states and Israel.

What is the Goal of the BDS Movement?

Ultimately, the BDS Movement would like to see the demise of the State of Israel. This goal is couched in language intended to create a veil of legitimacy around the BDS Movement, through its call for Israel to:

- Accept the right of return of Palestinian refugees to the modern State of Israel
- Provide full equality of Arab-Palestinian citizens according to Israeli law
- End the "occupation" and colonization of Arab lands, and dismantle the "Wall," or security barrier

Close Up

Full right of return of Palestinian refugees goes beyond United Nations recommendations on the issue and ignores the fact that the repatriation of Palestinian refugees to Israel would require the State to care for a population that jeopardizes its security and stability-something that even the UN does not require of Israel. Additionally, in Palestinian parlance, the "occupation" does not go back to the 1967 War, but is actually dated to 1948 when Israel was founded, and the War of Independence. When the BDS Movement calls for an end to "occupation" they are really calling for the demise of the Jewish state. Comparing Israelis to "colonizers" further contributes to the false image of Israel as an illegitimate state, despite the international community's recognition of the Jewish people's right to a state in their ancestral homeland.



Where does BDS focus its Efforts?

In its effort to paint Israel as a pariah state, the BDS movement attempts to destroy the goodwill of progressives toward the State of Israel and isolate it from other Western democracies. BDS initiatives are often geared toward academics, colleges, church associations, cultural institutions, artists, labor unions, and corporations.

BDS Today

According to the Fall 2015 Campus Trends Report, by the Israel on Campus Coalition, despite an overall decline in detractor activity relative to the 2014 fall semester, the number of schools affected by anti-Israel events increased slightly in 2015. The study also shows that there was a net decrease in anti-Israel campus activity in geographic regions across the country. By contrast, a steady increase in the amount of pro-Israel campus activity across all geographic regions was recognized.

Exposing the Lies

"Israel is an Apartheid state"

The BDS Movement commonly compares Israel to South Africa, seeking to equate the Jewish state with the apartheid regime. This is a fabricated allegation. Israel is a pluralistic, democratic society in which all of its citizens are equal before the law – in stark contrast to South Africa's policies under apartheid. The BDS Movement uses lies and exaggeration to defame Israel, along with misinterpretation of international law.

"Only an academic and consumer boycott of Israel will improve the situation of the Palestinians and bring peace"

The BDS campaign does not seek "ending occupation" nor "two states for two peoples." Rather, with "the right of return" demand central to the BDS agenda, the goal is the demise of the State of Israel. This is

what makes BDS the antithesis of a peace settlement as BDS nurtures an illusion of return, which actually perpetuates the conflict.

"The Gaza blockade violates international law and is only meant to make Palestinians suffer"

Israel withdrew from Gaza over a decade ago to enable Gazans to flourish and prosper under self-rule. Today, the great majority of the areas evacuated by Israel are used as terrorist training grounds by the Jihadist terror group, Hamas. The current situation is meant to prevent war by keeping rockets out. It is not illegal; it is legal to blockade a hostile entity. Any claim about its illegality is based on claim of occupation. Israel has no troops in Gaza, nor does it control all of its borders. The day Hamas acknowledges previous agreements and ceases the violence will be the day the blockade will be lifted.



"Israel murdered thousands of children in Gaza"

While Israel regrets any innocent lives lost to conflict, it is a country defending its citizens against Hamas, an internationally recognized terrorist organization. Hamas brutally forces Gaza's children to build cross-border attack tunnels, uses them as human shields, and launches rockets from densely populated areas. In contrast to Hamas, which shoots with the malicious intent to harm civilians, Israel takes extreme measures, more than any other army in the world, to avoid harm to innocent noncombatants. The blame falls on those who support terrorism, not on those who fight it.

"Israel is committing genocide on the Palestinian people"

"Genocide" literally means the deliberate, systematic and literal killing of a national, racial, political, or cultural group which results in a drastic reduction of a given population's numbers. In 1967, the total Palestinian population of Judea and Samara together with the Gaza Strip was about 955,000. In 2015, that number increased almost five-fold to 4.7 million. In contrast to terrorist organizations, which intentionally target civilians, Israel makes every effort not to harm innocent civilians in combat situations.

"The Palestinians want peace with Israel, but Israel does not want peace with them"

It takes two to tango, and Israel's attempts at peace have been rejected repeatedly over the years. The Arab representatives said "NO" to the 1937 Peel Commission Partition Proposal and "NO" to the 1947 U.N. Partition Plan. During the Oslo Peace Process in the 1990's Yasser Arafat said "NO" to the Israeli proposal at the 2000 Camp David summit. President Bill Clinton then presented new ideas for an agreement: which Israel accepted, but Arafat again refused, instead choosing to launch the Second Intifada. In 2005, Israel withdrew from the entire Gaza Strip. Since that time, terrorists have launched almost 20,000 rockets into Israeli cities and towns. Subsequent peace proposals were not only shot down by the Palestinians, they were also met with an escalation of violence.

"Israel's settlement policy is the source of the Arab-Israeli conflict"

Israel's actions make it clear that the Jewish Communities in Judea and Samaria are not the obstacle to peace. Israel evacuated thousands of Jewish citizens from the Gaza Strip hoping for peace, yet this only led to an increase in terror attacks from Gaza. The source of this conflict lies in the refusal of the Palestinian Authority to condemn terror and negotiate for peace.

"Israel does not let the Palestinian Authority manage the population in the Territories"

In most aspects of day-to-day existence,
Palestinians run their lives with no Israeli
involvement. Israel does retain control of the
overall security situation throughout Judea and
Samaria to ensure that terrorists do not gain
control as they did in Gaza. If that were to happen,
those harmed first and foremost would be the
Palestinians themselves.

"Israel should respect the Palestinians' 'Right of Return' in accordance with International Law"

There is no basis in international law for the so-called "Right of Return," which would turn the Jewish democracy into a Palestinian democracy. Return is not a requirement under international law, according to the UN High Committee on Refugees, the UN body that deals with the vast majority of the world's refugee issues.

"Arab citizens of Israel are second-class citizens"

The conditions of Israeli Arabs is far better than that of most Muslims in Europe. Israeli Arabs not only enjoy equal rights under the law, they also serve as Members of Knesset and judges (including the Supreme Court). Israeli Arabs also

serve abroad as diplomats and in the IDF. There are numerous other examples of Israeli Arabs taking leadership roles in Israeli culture, art, economy and academia.

"Israel's Apartheid wall is a violation of international law and must be torn down in order to ensure human rights"

All countries have a right under international law to build fences to protect their citizens. No one can deny that the security barrier saves lives. It was raised to stem the daily flow of Palestinian suicide bombers who were penetrating the porous borders and perpetrating heinous attacks that killed upwards of 1,000 Israeli men, women and children. The UN has ruled that the barrier is 100% legal.

"Companies that do business in the West Bank violate universally-accepted human rights"

Companies do not violate human rights by doing business in Judea and Samaria. In fact, by investing in these areas numerous companies have raised the standard of living for Palestinians, provided decent wages, and made sure to respect Israeli labor laws for all employees. Jews and Palestinians both work for companies in Judea and Samaria, often giving them a rare chance to interact. Many Palestinians do not support BDS and may lose their livelihoods because of the Movement.

TAKING ON BDS: Best Practices

BDS' tentacles have reached nearly all areas of society, but its major thrust can be seen on

college campuses.

There, the BDS Movement uses dishonest rhetoric about "social justice" and "human rights" to appeal to young people - our future leaders and opinion makers.



FULL-ON undertaking.

One that requires nerves of steel, dedication and an army of supporters who will rise to the rallying cry. Students have to be motivated, well-organized, strategic, informed, and have the backing of the pro-Israel community.

They need training, effective strategies, engaging and informative content, funding and, when necessary, crisis intervention. Moreover, with a complete turnover of students every four years, the leadership model cannot be based upon specific students but needs to be long-term and sustainable. In the majority of situations, this will require the strong, proactive involvement of alumni, professors, organizations and the local Jewish community.

Strategies and Tools

Activate your network. Join pro-Israel groups on campus. Learn as much as you can about their various initiatives, and write articles/op-eds for your college's alumni magazine and campus newspaper. Contact your elected officials and encourage them to draft legislation that outlaws academic boycotts of Israel.

Drive a wedge between the delegitimizers and the critics

by focusing on those who are Israel-deniers and anti-Semites: Out-name-shame the delegitimizers, focusing all available fire-power – whether financial, social, legal etc. – to expose the individual and prevent them from operating in the campus, labor union, or any other forum.

It's a clash of brands. Build your brand

and fight their brand - The BDS Movement brands Israel and Jews as oppressors, manipulators and power brokers, serial violators of international law and of human rights, and the source of all evil, thus tapping into classic anti-Semitic notions. Meanwhile the Palestinians are framed as the powerless victims of Israel and the Jews. Israel's brand is all about do good creative energy - embodied by the Start-Up Nation concept and associating Israel with innovation, creativity, and contribution to humanity.

It takes a network to fight a network

This means that no one can win this fight on their own, as there is no silver bullet, and success requires all elements of the community to do their share. Strengthen the ability of pro-Israel leaders to wage effective local campaigns by building broad coalitions. Your coalition should then create its own hub and strengthen its capacity to combat BDS. Once equipped with the necessary tools, the pro-Israel hub should identify and target the global and local BDS network, and work aggressively to expose their fallacies.



P.E.E.R. Approach

Over the years, research and experience has found that the case for Israel can be made most effectively if you keep in mind the following guidelines: Peace, Empathy, Emotion, Rhetoric.

Peace

In most debates, the speaker who comes across as most reasonable and in favor of peace is the one who wins. Thus, whenever you speak about Israel, every other word out of your mouth should be "peace." Every action Israel takes is dedicated to attaining "peace," and creating conditions for "peace." "Peace, peace, peace."

Emotion

Emotional stories are highly persuasive. Instead of using abstract statistics, convey the daily psychological strain and danger Israelis face, tell a true story that your listeners can understand.

Empathy

Too often supporters of Israel resort to demonization or generalization of the other side. While it is useful to point out contrasts between Israel and the Arab states, you lose your audience if you start to talk in generalizations about "the Arabs" or "the Muslims." Instead, it is important to acknowledge valid points the other side may have and then turn make the case for Israel.

Rhetoric

It is easy to criticize from afar, and to condemn the results of an action, but try to force critics to put themselves in Israel's shoes. Let them try to come up with better solutions to Israel's dilemmas.

Not every Israeli action needs to be defended, but they should be put in context. And not everyone will be convinced of your arguments, no matter how persuasive.



Effectively Countering Israel Apartheid Week

The BDS Movement commonly compares Israel to South Africa, seeking to equate the Jewish state with the Apartheid regime.

One of their most effective tactics is Israel Aparheid Week, an annual spring event held at campuses worldwide. Campuses hold events, host speakers, screen films and construct "Apartheid" walls and checkpoints.

To effectively counter Israel Apartheid Week it is essential to think Big Picture and long-term, in essence, to develop a year-long strategy that fosters dialogue and the legitimacy of Israel as a Jewish state.

One example that shows how the BDS movement has influenced an international organization occurred in March 2016. The UN Human Rights Council passed a resolution, initiated by the Palestinians, obligating the organization to compile a blacklist of all Israeli and international firms operating directly or indirectly in Judea and Samaria, Jerusalem and the Golan Heights.









Formulate a **Proactive Strategy**

Do not sit back and wait for others to assail Israel. Instead of reacting, it is important to set the agenda. Four simple words, "Build Bridges, Not Boycotts" truly define what the public and America's youth thinks the solution for the conflict in the Middle East should be.

Build Relationships

According to the Fall 2015 Campus Trends Report, by the Israel on Campus Coalition, BDS supporters greatly broadened the reach of their activism by expanding relationships with campus and community partners. It is a highly effective tactic that pro-Israel groups should also employ.



Reach out to the Community

Your greatest ally in the BDS fight is the Jewish community. Ask the campus professional to help you contact the appropriate community organizations and contact the Israel on Campus Coalition, which represents all of the major organizations that work with students. Be in touch with the local Jewish Community Relations Council or the nearest Jewish Federation.

If any campus activities have anti-Semitic aspects, contact the nearest Israeli consulate, or the Anti-Defamation League (ADL). They should have someone who deals with academic affairs and will want to be in the loop that can help with materials, information and other resources or speakers.

Connect to the Student Government

While some student governments do not pass resolutions regarding controversial political affairs, many do, and these schools have become targets of the Boycott, Divestment, and Sanctions Movement (BDS). Forge strong bonds between the government and the pro-Israel and Jewish student communities.

Cultivate Relations with Ethnic, Racial and Religious Groups

Non-Jewish ethnic and religious groups often know the least about Israel and the history of the Jewish people and, thus, are often easy targets for the BDS Movement. Jewish student leaders need to reach out to these groups and forge friendships by working on common causes and public service projects; we also need to support their causes whenever possible if we expect them to be there for us.

Bond with the Progressive Student Groups

The BDS Movement has sought to co-opt progressive and liberal student groups by convincing them that Israel is inherently bad and that only BDS offers a moral path committed to human rights. Show them the true face of Israel, and the progressive state it is. Shatter the lies and host events on liberal topics together.

The Role of Faculty

Faculty are key stakeholders in the campus community and can, when organized and informed, play critical and key roles in ensuring that the debate on campus remains honest. Faculty are responsible for upholding academic standards on campus and for elevating the quality and level of complex discussions on campus, such as the Arab-Israeli conflict, among other issues.

Contact University Trustees

The Board of Trustees is the governing board, legal owner, and ultimate decision-maker of independent, nonprofit, and public colleges and universities. The Board has extensive influence on a campus and can be an ally in the struggle against delegitimization of Israel.

Using the Power of the Law against BDS:

Know your Rights



Free Speech

According to the First Amendment, you have the right to express your opinions without being censored or restrained by the government. Public schools may not violate the First Amendment's protections of free expression because they are considered government entities; but they may impose reasonable time, place, and manner restrictions on expression. Private schools have more leeway to restrict or even prohibit free speech because they are not government entities. However, many private universities have chosen to adopt First Amendment principles regulating campus speech, and some states have extended First Amendment protections to private universities.

Viewpoint Discrimination:

A university may not deny funding for an event it would otherwise fund because it does not agree with the viewpoint advocated at the event.

Academic Freedom for Teaching

Faculty members have a right to develop and espouse original and controversial ideas. However, according to professional standards, professors should avoid teaching controversial matters that have no relation to the subject(s) they teach.

Hate Speech While hate speech is generally protected by the First Amendment, it may be restricted if it threatens or incites violence. If hate speech occurs during the commission of a crime, it becomes a hate crime. You can demand that your campus administration condemn hate speech.

Guidelines on responding to anti-Israel and anti-Semitic content on the Internet

FLAG

Many sites, such as YouTube, allow users to flag offensive content for review. Many sites also allow you to say why you thought something was offensive – in these cases, make sure to include detailed comments.

RECORD

Take screenshots of offensive content.

SPEAK

Post videos or comments that oppose the offensive point of view. Let the online community see a competing perspective.

SUPPORT

Don't forget to post positive comments that share positive messages about Israel and about Jews.

KNOW

Familiarize yourself with the online platform you are using. Look for a site's Terms of Service or Community Guidelines

Harassment

Most universities have anti-discrimination and anti-harassment policies to protect students from harassment by others. The code serves as a contract between the students and university. If anti-Israel students falsely accuse pro-Israel students of discrimination in violation of campus policy, this may constitute harassment.

Navigating School Administrative Systems

Responding to anti-Semitic and anti-Israel activity can be difficult, but there are substantial resources to help and support you through the administrative process. Research your school's policies and bylaws for relevant rules.






